## NOTIFICATION

Aizawl, the 21st of October, 2020.

No.D.33011/36/2020-HFW(QM)/8: In the interest of public service, the Competent Authority is pleased to notify that exemption from quarantine may be given to person(s) coming from other states for short stay to perform and attend to personal or official business provided that they fulfill the following terms and conditions.

## Terms and Conditions

- He/she shall fulfill the formalities for registration and screening as prescribed by Home Department, Government of Mizoram from time to time.
- He/she, on arrival, shall report himself/herself to the COVID-19 Screening Point for Rapid Antigen Test.
- 3. To avoid having to undergo COVID-19 testing upon arrival, he/she should produce a 'negative' report of RT-PCR/TrueNat/CBNAAT test for COVID-19 provided that such test was conducted within 96 hours prior to the time of arrival in Mizoram.
- 4. The 'negative' test report/certificate should bear a valid Specimen Referral Form (SRF) ID number for authentication.
- 5. Upon fulfilling the conditions at Point No.(1) to (4), the person shall be allowed to perform and attend to his/her business without undergoing quarantine. However, his/her movement within the State will be regulated as per 'Category C' of Notification No.B.13021/101/2020-DMR/Pt-III dated 20.07.2020 issued by Disaster Management & Rehabilitation Department, Government of Mizoram.
- He/she shall scrupulously follow all COVID-safety protocol, such as wearing of mask in the presence of others, maintaining social distance and observing hand and respiratory hygiene.

This Notification shall come into immediate effect and remain in force until further orders.
