**ORDER**

A partial modification of Order No.B.13021/101/2020-DMR/VOL-III dt.16.01.2021 in respect of certain clauses is hereby made as follows:

- a.** Clause I(A) (2) & (3) shall be replaced as follows:
1. Persons entering Mizoram from other parts of the country shall undergo thorough screening at the points of entry. Those having negative test results of RT- PCR/TrueNAT/CBNAT from ICMR-recognized laboratories not older than 96 hours prior to their arrival shall not be required to undergo COVID-19 tests and quarantine.
  2. Persons without RT-PCR/TrueNAT/CBNAT negative test results from ICMR recognized laboratories shall undergo Rapid Antigen Test (RAgT) at the entry points. Those testing positive shall be treated as per existing protocol and those testing negative shall be exempted from quarantine. This protocol shall also apply to all persons travelling from and returning to Mizoram.
  3. Those entering Mizoram from outside and having RAgT negative results and not requiring quarantine shall observe strict self-monitoring for seven days mandatorily.
- b.** In Clause 1(A) (4), **Europe** shall be substituted with '**Persons coming from foreign countries where cases of COVID-19 UK variant is reported**'. They shall be quarantined as per regulations issued by Health & Family Welfare Department. However, if they had been in India for not less than 10 days before arrival, and if they possess negative certificate of RT- PCR/TrueNAT/CBNAT tests from IMCR-recognised Laboratories or if they have RAgT negative result at the point of entry in Mizoram, they will not be required to undergo quarantine. Nevertheless, if the duration of their stay in India had not been 10 days upon entering Mizoram, they shall be treated as coming from foreign countries and shall undergo mandatory quarantine.
- c.** The following provisions are added under **Clause I(E)(1)-**
- 1(a). Reopening of schools and hostels for Class X and Class XII students will commence from 22.02.2021 onwards. All students shall undergo mandatory thermal test, and students to be admitted to hostels shall possess negative RT-PCR/TrueNAT/CBNAT test results not older than 96 hours. SoPs issued by School Education Department shall be strictly adhered to.

**d. Clause I(E)(2)** is altered as follows:

Colleges and Universities, along with their hostels are allowed to be opened from February, 2021. However, Higher & Technical Education Department shall conduct an on-site inspection of their preparedness and arrangements made and then issue their concurrence prior to opening. Moreover, the SoPs to be followed in these institutions shall be prepared and issued by Higher & Technical Education Department with the approval of Health & Family Welfare Department and Disaster Management & Rehabilitation Department. The aforesaid SoP should be strictly adhered to.

**e. Clause I(E)(3)** is altered as follows:

Training/skill training/coaching/vocational institutions are allowed to re-open. However, 50% of the room's seating capacity shall only be allowed to be filled at one point of time. The SoPs to be regulated in these venues shall be as per the SoP issued by Higher & Technical Education Department.
