GUIDELINES FOR ALLOTMENT OF HOTELS AS QUARANTINE FACILITIES

Quarantine at the empanelled hotels shall be done as per the procedure given below:

- 1. Any person who wishes to be quarantined at any of the empanelled hotels, list at *Annexure I*, shall apply in writing to the Deputy Commissioner concerned well ahead of the date of departure from the originating station. They will clearly state their willingness to be quarantined at the empanelled hotels at their own expense which will include fooding and lodging.
- 2. Once the application is received, the Deputy Commissioner/ Chairman, District Level Task Force shall allot the hotel under intimation to the health authorities/Quarantine Management Unit, Health & Family Welfare Dept. However, only those person(s) who clear the Rapid Antibody Test upon arrival at the designated location to be arranged by the Deputy Commissioner shall be allowed to proceed/check in to the hotel.
- 3. The Deputy Commissioner shall share all relevant information regarding persons quarantined at hotels with the Task Group on Quarantine Facilities.
- 4. Any person(s) quarantined at a hotel shall not be allowed to have visitors or mingle with other guests and all social distancing norms shall be followed in their interaction with hotel staff. The responsibility of ensuring this will lie with the management and a written undertaking to this effect shall be obtained from the owner of the hotel by the Deputy Commissioner (format of undertaking at *Annexure-II*).
- 5. Meals shall be served to quarantined persons in their rooms and under no circumstances shall they dine with other guests in the hotel restaurant.
- 6. No person(s) quarantined at the hotel shall be allowed to check out unless discharged by the Deputy Commissioner/Chairman, District Level Task Force.
- 7. Social distancing and hygiene norms as well as respiratory hygiene/coughing etiquette shall be observed at all times by both quarantined person(s) and hotel staff.
- 8. If the quarantined person develops cough, fever, shortness of breath, or respiratory or any other illness during the quarantine period, the same shall be immediately reported to the Helpline numbers 101/(0389)2318377/(0389)2323336.
- 9. Any person(s) quarantined at hotels shall compulsorily register themselves in the Aarogya setu and mCovid-19 mobile applications.
- 10. The hotels shall also ensure that the terms & conditions stated in the notification of empanelment are strictly adhered to.

THE MIZORAM (CONTAINMENT AND PREVENTION OF COVID-19) **ORDINANCE**, 2020

AN **ORDINANCE**

to contain and prevent the spread of Covid-19 in the State of Mizoram and matters connected therewith and incidental thereto.

WHEREAS the Legislative Assembly of Mizoram is not in session, and the Governor of Mizoram is satisfied that circumstances exist which render it necessary for him to take immediate action:

NOW, THEREFORE, in exercise of the powers conferred by clause (1) of article 213 of the Constitution, the Governor of Mizoram is pleased to promulgate the following Ordinance, namely:-

CHAPTER -I **PRELIMINARY**

- 1. Short title and Commencement.—
- 1) This Ordinance may be called the Mizoram (Containment and Prevention of Covid-19) Ordinance, 2020.
- 2) It shall extend to the whole of Mizoram.
- 3) It shall come into force at once.

2. Definitions.—

- 1) In this Ordinance unless the context otherwise requires,-
- a) 'authorized persons' means persons authorized under section 3 of this Ordinance.
- b) 'competent authority' means any authority or person(s) authorized by the State/Central Government from time to time for the purpose of containment and prevention of COVID-19.
- c) 'Government' means the Government of Mizoram.
- d) 'mask' includes a covering made of any material in any form which is used to cover the nose and mouth sufficient/adequate enough to prevent the transmission and spread of COVID-19.
- e) 'public place' means any place to which the public have access, whether as of right or not, and includes hospital and all health centres, amusement centres, parks, playgrounds, hotels and restaurants, public offices, work places, educational institutions, libraries, public transport vehicles including its stands and stations, railway station, airport, public road, stadium, auditorium, community hall/centres, commercial establishments, gyms, market place/area, shopping malls, public/local wholesale and retail shops, petrol pumps, religious institutions and the like which are visited by the general public.
- f) 'regulations' means The Mizoram Epidemic Diseases (COVID-19) Regulations, 2020 as amended from time to time.
- g) 'social distancing' means the practice of maintaining a physical distance by at least 6 (six) feet from other person so as to avoid direct contact with other persons in public places and any other private/public/social gathering for prevention of transmission and spread of COVID -19.
- h) 'spitting' means the act of ejecting saliva, sputum or any other liquid or solid substances which includes kuhva, gutkha, pan masala, zarda, tuibur or any other tobacco product in any form from one's mouth and/or nose.
- i) 'State' means the State of Mizoram.

2) The words and expression used herein and not defined but defined in the Mizoram Epidemic Diseases (COVID-19) Regulations, 2020 shall have the same meanings respectively assigned to them in the said regulations.

3. Authorised persons

to impose & collect fines.— Authorised persons to impose and collect spot fines for violation of this Ordinance, regulations, guidelines or any other instructions issued by the Government with regard to containment and prevention of the spread of Covid-19 shall be as follows:-

- 1) any Executive Magistrate.
- 2) any Law Enforcing Officer authorised by the Government.
- 3) any police officer not below the rank of Constable.
- 4) Chairman/Vice-Chairman/Member Secretary of State Level Task Force on COVID-19.
- 5) Chairman/Vice-Chairman/Member Secretary of District Level Task Force on COVID-19.
- 6) Chairman/Vice-Chairman/Member Secretary of Village/Local Level Task Force on COVID-19.

CHAPTER – II OFFENCES AND PENALTIES

4. Offences.—

The following acts or omissions shall be considered to be offences under this Ordinance:-

- 1) entering or staying at any public place without the use of mask;
- 2) failing to maintain social distancing protocol/guidelines in public places;
- 3) spitting in public places;
- 4) organising any social or religious event without prior permission from the competent authority;
- 5) crossing borders by exiting and/or entering the State without permission from the competent authority;
- 6) avoiding or attempting to evade quarantine and/or isolation at designated quarantine facility as per regulations/guidelines/instructions in force from time to time;
- 7) leaving or escaping the designated quarantine/ isolation facility before completion of the stipulated time;

- 8) failing to follow instructions/guidelines and endangering the safety of others while staying at designated quarantine facility;
- 9) failing to comply with any other regulations guidelines or instructions made by the Central or State Government for containment and prevention of the spread of Covid-19 including lockdown guidelines issued by the State Government from time to time;
- 10) (a) exposure/display of the identity of Covid-19 positive patient and suspected persons by sharing their bio-data and/or photo in print, electronic and social media without prior permission from the competent authority.
 - (b) for the purposes of sub-section (10), the offence shall be non-cognizable, non-compoundable and bailable, triable by any Judicial Magistrate.

5. Penalties.—

Whoever contravenes the provisions of section 4 of this Ordinance shall be punished as follows:-

- 1) for contravening sub-section (1) with fine amounting to Rs.100/-.
- 2) for contravening sub-section (2) with fine amounting to Rs.200/-.
- 3) for contravening sub-section (3) with fine amounting to Rs.300/-.
- 4) for contravening sub-section (4) with fine amounting to Rs.5000/-.
- 5) for contravening sub-section (5) with fine amounting to Rs.5000/-.
- 6) for contravening sub-section (6) with fine amounting to Rs.3000/-.
- 7) for contravention of sub-section (7) with fine of not less than Rs.1000/- which can be extended upto Rs.5000/-.
- 8) for contravening sub-section (8) with fine amounting to Rs.500/-.
- 9) for contravening sub-section (9) with fine amounting to Rs.1000/-.
- 10) for contravening sub-section (10) with simple imprisonment for a term which may extend to 3 months or with fine which may extend to Rs.5000/- or with both.

CHAPTER – III MISCELLANEOUS

6. Records of fines imposed.—

The persons authorised to impose and collect fines under this Ordinance shall maintain proper records of all fines imposed in a separate register and such record shall include all the details specified in the receipt/challan in triplicate as provided in the Annexure.

- 7. Detention of offenders.—
- (1) Whoever fails or refuses to pay the stipulated fines or refuses to provide the information required under section 6 shall be detained on the spot until payment of such fine and/or furnishing such required information, security or surety.
- (2) In default of payment of the fines, security/surety within 24 hours, the offender shall be imprisoned for a term which may extend to 4 months.
- (3) For the purposes of this section, the offence shall be non-cognizable, non-compoundable and bailable, triable by any Judicial Magistrate.
- 8. Depositing of fines.—

The authorised persons shall submit the fines collected under section 5 to the Deputy Commissioner of the district concerned along with all the records maintained under section 6 on the last working day of every month. The Deputy Commissioner shall cause the fines so collected to be deposited in the State Treasury.

9. Ordinance not in derogation of any other law.—

The provisions of this Ordinance shall be in addition to and not in derogation of the provisions of any other law for the time being in force.

10. Protection of action taken in good faith.—

No suit, prosecution or other legal proceeding shall lie against any person authorised under this Ordinance for anything which is done or intended to be done in good faith under this Ordinance.

11. Power to remove difficulties.—

(1) If any difficulty arises in giving effect to the provisions of this Ordinance, the Government may, by order published in the Official Gazette, make provisions not inconsistent with

- the provisions of this Ordinance which appear to it to be necessary or expedient, for removing the difficulty.
- (2) Every order made under this section shall, as soon as may be after it is made, be laid before the Legislative Assembly
- 12. Power to make rules.—
- (1) The Government may, by notification in the Official Gazette, make rules either prospectively or retrospectively for the purpose of carrying into effect the provisions of this Ordinance.
- (2) Every rules made under this Ordinance shall be laid, as soon as may be after it is made, before the Legislative Assembly while it is in session and/or if the Legislative Assembly makes any modification in the rule or decides that the rules should not be made, the rules shall thereafter have effect only in such modified form or be of no effect, as the case may be, so however, that any such modification or annulment shall be without prejudice to the validity of anything previously done under that rules.

ORDER

Consequent upon the announcement of resumption of domestic flights w.e.f 25th May, 2020 by the Ministry of Civil Aviation, Government of India, and in view of the current CoVid-19 pandemic situation, it is necessary to lay down certain guidelines and procedure to be followed by persons entering the State of Mizoram by flight through Lengpui Airport. Therefore, in the interest of public service, it is hereby ordered that all permanent residents of Mizoram and all Government servants stranded outside the State due to CoViD-19 lockdown who intend to enter Mizoram by flight through Lengpui Airport shall abide by the following rules and procedure with immediate effect and until further orders:

- 1) All such persons shall intimate their flight & ticket details to the resident representative of the Government of Mizoram (Resident Commissioner, New Delhi/Jt. Resident Commissioner, Kolkata/Dy Resident Commissioner, Guwahati/Shillong/Silchar) located in the station where they are currently stranded. In States/cities where a resident representative (Mizoram House) is not located, such details may be reported through the nearest Mizo Welfare Associations. Such persons shall give their full particulars as per the proforma attached in Annexure 1. Any person furnishing false information or found to conceal information shall be liable to be penalised.
- 2) No person shall board any flight bound for Lengpui Airport without obtaining prior permission from Home Department, Government of Mizoram, and any person arriving at Lengpui Airport without movement permit shall not be allowed to leave the airport.
- 3) The list of passengers shall be sent to the Chairman, Task Group on Migrant Workers & Stranded Travellers who shall submit a compiled list for every flight, destination-district-wise, to Home Department by 2:00 P.M of the day prior to the date of departure of the flight, for approval.
- 4) All persons arriving at Lengpui Airport shall undergo mandatory screening for CoVid-19 symptoms and Rapid Antibody Test, or as prescribed by the State Government from time to time.
- 5) All persons arriving at Lengpui Airport from areas declared as Red Zones by the Ministry of Health & Family Welfare, Government of India shall undergo RT-PCR test after arrival at their respective quarantine locations, in addition to the Rapid Antibody Test done at Lengpui Airport.

- 6) All persons shall undergo mandatory quarantine for 14 days as assigned by the respective Deputy Commissioners.
- 7) All persons arriving by flight at Lengpui Airport shall proceed to their respective quarantine facilities via their designated arrival/transit points as applicable, only by means of transportation arranged by the Deputy Commissioners concerned. No other pick-up arrangement shall be allowed unless permitted by the same authority.
- 8) Until further orders, persons other than those mentioned in the first paragraph, shall obtain prior permission of Home Department, Government of Mizoram before booking their flight tickets for Lengpui airport.
- 9) In addition to the procedure aforementioned, all persons arriving at Lengpui Airport shall abide by the SOPs prescribed by the Government of Mizoram, as well as the guidelines issued by the Ministry of Civil Aviation, Government of India vide Order No.AV.29017/5/2020-DT dated 21.05.2020 which is available in the Ministry's website at www.civilaviation.gov.in. As per the pre-departure guidelines issued by the MoCA, all passengers shall certify the status of their health through the Aarogya Setu mobile app, or through a self-declaration form as given in Annexure 2.

STANDARD OPERATING PROCEDURE FOR REPATRIATION OF MIGRANT WORKERS AND TRAVELLERS STRANDED IN MIZORAM DUE TO COVID-19 LOCKDOWN

- 1. Stranded persons desirous of moving from Mizoram to any other place in India shall apply to the Deputy Commissioner concerned.
- 2. Stranded persons desiring to move out (personally or with assistance from others) shall apply to the Deputy Commissioner concerned indicating their names, EPIC/Aadhaar details, contact number, names of persons in the group, originating locality, village/town and district in Mizoram,their full postal address at the destination State. List of contact numbers of Deputy Commissioners with e-mail address is appended as *Annexure-I*. Districts shall compile this information which will be consolidated destination statewise and submitted to the Officer-in-Charge appointed for the destination State concerned. List of Officers-in-charge is appended as *Annexure-II*. The Deputy Commissioner will send the list of passengers to the Officer-in-Charge and to Sub-Divisional Officer(C) Vairengte in PDF format.
- 3. The Officer-in-Charge shall forward the applications to their counterparts in the destination State(s) and the State(s) to be transited (if any) and request permission for their return.
- 4. Upon receipt of permission from the destination State(s) and the State(s) to be transited (if any), inter-state movement permit will be issued by Home Department.
- 5. The Deputy Commissioner concerned, in consultation with the Officer-in-Charge for the State concerned, will prepare the movement plan for migrant labourers/ workers and travelers of other states stranded in their respective districts. The Deputy Commissioners will prepare destination state-wise list of migrant workers and travelers and submit the same to the Task Group on Migrant Workers and Stranded Travellers.
- 6. Stranded patients, students, business travelers and tourists having their own transportation will be allowed to move after obtaining necessary passes, while those who do not have their own transportation will be allowed to move in groups in an orderly and planned manner, after transportation arrangements have been finalized in consultation with the receiving States.
- 7. The Officers-in-Charge shall liaise with their counterparts of the other States regarding the movement schedule along with the mode of transportation to be arranged and shall submit the detailed report to the Task Group on Commodities and Transport. The Task Group on Commodities & Transport, in collaboration with the Deputy Commissioners concerned, shall make necessary arrangements for hiring of the required vehicles.

- 8. Cost of hired transportation will have to be paid for by the person or group of persons desiring to move out. Alternatively, if the receiving State wants to hire transportation for their residents stranded in Mizoram, they will be free to do so after movement plan has been prepared for each district and consolidated by the respective State Nodal Officer of the receiving State.
- 9. District authorities will facilitate bus owners in disinfecting buses which are used to move persons from their respective districts. Social distancing norms and compulsory use of face mask will be observed throughout the journey.

REVISED GUIDELINES FOR ALLOTMENT OF HOTELS/ HOME STAY AS QUARANTINE FACILITIES

Quarantine at the hotels/ home stays shall be done as per the procedure given below:

- a) Any person who wishes to be quarantined at a particular hotel/home stay shall apply in writing to the Deputy Commissioner concerned well ahead of the date of departure from the originating station. They will clearly state their willingness to be quarantined at the hotels/home stays at their own expense which will include fooding and lodging and subject to the conditions stipulated in these guidelines. The application shall also be accompanied with a No Objection Certificate issued by the LLTF/VLTF of the locality concerned.
- b) Once the application is received, the Deputy Commissioner/Chairman, District Level Task Force shall allot the hotel/home stay under intimation to the health authorities/Quarantine Management Unit, H&FW Dept. However, only those person(s) who clear the Rapid Antibody Test upon arrival at the designated location to be arranged by the Deputy Commissioner shall be allowed to proceed/check in to the hotel.
- c) The Deputy Commissioner shall share all relevant information regarding persons quarantined at hotels/ home stays with the Task Group on Stranded Migrants and Travellers and State Control Room in the prescribed format.
- d) Any person(s) quarantined at a hotel/ home stay shall not be allowed to have visitors or mingle with other guests and all social distancing norms shall be followed in their interaction with hotel staff.

- e) Meals shall be served to quarantined persons in their rooms and under no circumstances shall they dine with other guests in the hotel restaurant.
- f) No person(s) quarantined at the hotel/ home stay shall be allowed to check out unless discharged by the Deputy Commissioner/Chairman, District Level Task Force.
- g) Social distancing and hygiene norms as well as cough etiquette shall be observed at all times by both quarantined person(s) and hotel staff.
- h) If the quarantined person develops cough, fever, shortness of breath, or respiratory or any other illness during the quarantine period, the same shall be immediately reported to the Helpline numbers 102/(0389)2318377/(0389)2323336.

- i) Any person(s) quarantined at hotels shall be advised to register themselves in the *Aarogya setu* and *mCovid-19* mobile applications.
- j) The hotels/ home stays shall also ensure that the following terms & conditions are strictly adhered to.

- a) The tariff shall not be altered without prior notice of at least 7 days.
- b) The Government reserves the right of allotment of persons to the hotels. No direct booking by persons requiring quarantine shall be made with the hotel.
- c) All hotels/ home stays willing to check in quarantined guests_will furnish a written undertaking to the effect that they will ensure that the quarantined guests do not have visitors or mingle with other guests, that they observe social distancing and hygiene protocol scrupulously (Annexure).
- d) Other guests shall not be allowed to check in once hotels/ home stays have admitted persons for quarantine.
- e) The hotel management may contact the State Control Room (1070 / 2335842/ 2335837/ 9366331931) in case of non-medical issues/queries and Helpline {102/ (0389)2318377/ (0389) 2323336} in case of medical issues /queries.
- f) The linens, towels etc, rooms, should be disinfected and strict hygiene and sanitation practices should be followed.
- g) In-house catering should provide only room service for freshly cooked food duly following physical distancing and environmental sanitation.

NOTIFICATION

No.D.33011/21/2019-HFW(nCOV), the 25th March 2020: In exercise of the powers conferred under section 2, 3 & 4 of The Epidemic Diseases Act, 1897 (Central Act 3 of 1897), the Government of Mizoram, for the interest of public health and safety is pleased to issue the following regulations to amend the Mizoram Epidemic Diseases (COVID-19) Regulations, 2020 as follows:

- 1. These regulations may be called "The Mizoram Epidemic Diseases (COVID-19) (First Amendment) Regulations, 2020".
- 2. They shall be deemed to come into force on the 18th day of March, 2020.
- 3. In "The Mizoram Epidemic Diseases (COVID-19) Regulations, 2020" (hereinafter referred as the principal regulations):-
 - (1) for sub-regulation (6) of regulation 2 of the principal regulations, the following shall be substituted, namely
 - (6) "designated quarantine facility" means any facility declared by the State Government or the State Executive Committee of Mizoram State Disaster Management Authority for the purpose of quarantine of asymptomatic cases.
 - (2) in regulation 2, after sub-regulation (10) of the principal regulations, the following sub-regulation shall be inserted, namely
 - (11) "District Disaster Management Authority" means the District Disaster Management Authority constituted under section 25 of the Disaster Management Act, 2005
 - (3) in sub-regulation (1) of regulation 3 of the principal regulations, after clause (p), the following clauses shall be inserted, namely-
 - (q) Director General of Police, Mizoram
 - (r) Secretary, GAD
 - (s) Secretary, Disaster Management and Rehabilitation Department
 - (t) Secretary, Food Civil Supplies & Consumer Affairs Department

- (u) Secretary, Tourism Department.
- (v) Secretary, Higher & Technical Education Department.
- (w) Secretary, School Education Department.
- (x) Secretary, Commerce & Industries Department.
- (y) Secretary, AH & Vety Department.
- (4) in sub-regulation (2) of regulation 3 of the principal regulations, after clause (1), the following clause shall be inserted, namely:
 - (m) Chairman, Village/Local Level Task Force on COVID-19 constituted in pursuance of the instructions given by the State Government for the prevention and containment of the outbreak and spread of COVID-19 (within their respective jurisdictions).
- (5) in regulation 10, after sub-regulation (4) of the principal regulations, the following sub-regulation shall be inserted, namely:
 - (5) To undertake any such other preventive and containment measures as instructed by the State Government from time to time for the prevention and containment of the outbreak and spread of COVID-19.
- (6) for regulation 11 of the principal regulations, the following shall be substituted, namely:
 - "11. Powers of Chief Secretary and District Collector/ Deputy Commissioner to implement and execute preventive and containment measures to prevent and contain the outbreak and spread of COVID-19 in the State of Mizoram or any part thereof-
 - (1) In cases of compelling reasons and on sufficient grounds where it is necessary and required to use certain preventive and containment measures to prevent and contain the outbreak and spread of COVID-19 in the State of Mizoram or any part thereof, the District Collector/Deputy Commissioner of the concerned district shall have the right to implement and execute the following preventive and containment measures under his/her jurisdiction, but not limited to these, in order to prevent and contain the outbreak and spread of COVID-19 namely:
 - (a) Sealing of geographical area.
 - (b) Barring entry and exit.
 - (c) Closure of schools, offices, institutions or any establishments.
 - (d) Closure of shops, malls, market places and other public places.
 - (e) Banning public gatherings.
 - (f) Banning vehicular movement.
 - (g) Initiating active and passive surveillance of COVID-19 cases.
 - (h) Hospital isolation of suspected cases.
 - (i) Designating any building as a quarantine facility or containment unit for isolation of the cases
 - (j) Any other measures as directed by the State Government from time to time to prevent and contain the spread of COVID-19.
 - (2) Staff of all Government Departments under the Government of Mizoram of the concerned area shall be at the disposal of the District Collector/ Deputy Commissioner for discharging the duty of preventive and containment measures. If required, the District Collector/

Deputy Commissioner may requisite the services of any other person or persons. In addition, services may be outsourced and persons may be engaged under short term contracts".

Provided that the Chief Secretary of Mizoram shall have the power to implement and execute all the preventive and containment measures hereinbefore mentioned in cases where such measures are necessary or expedient in the public interest to be implemented and executed in the entire state of Mizoram to prevent and contain the outbreak and spread of COVID-19."

- (7) for regulation 12 of the principal regulations, the following shall be substituted, namely:
 - "12. Authorization of District Disaster Management Authority for planning strategy etc. regarding preventive and containment measures.-

The District Disaster Management Authority shall undertake all necessary measures for prevention and containment of COVID-19 in the district, such as planning, organizing, coordinating and implementing measures in accordance with extant acts, rules, regulations and guidelines, or as deemed appropriate, in the interest of the public. The District Disaster Management Authority may co-opt other officers from different Departments or local bodies, community based organizations or any NGO's, as deemed necessary for this purpose."
